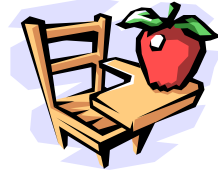

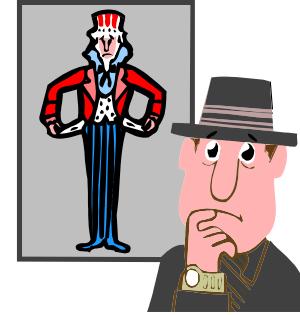

Receive a State Income tax credit for the full amount you contribute to a public school up to \$400.00 for married couples filing a joint return. Individuals filing as single, married filing separate returns or head of household may contribute up to \$200.00.

➤ ***Here's your chance!***

Arizona tax law (ARS 43-1089.01) allows taxpayers a tax credit of up to \$400.00 (for married couples filing a joint return) if they contribute to extracurricular activities in public schools. Extracurricular activities such as sports, band, intersession classes, summer school or field trips are many times not fully funded by school districts. Frequently these programs depend on fees from students.

➤ ***You need not be a parent to win!***

A tax credit is available to all taxpayers, regardless of whether they have children in school.

➤ ***It's this easy!***

If you want to support one or more of the programs listed on the response card, simply write a check to the school or schools of your choice. Mail the check or deliver it to the school with your completed response card. The school staff will provide you with a receipt verifying that you have contributed to an eligible extracurricular activity. Next spring, simply claim your tax credit. This credit, if not fully utilized to offset state tax owed, may be carried over for 5 years.

➤ ***Know the difference***

Contributions to public schools have always been tax deductible. A tax deduction allows you to subtract the amount of a contribution from the amount of your taxable income. The law allows a tax credit, which is subtracted from the amount of taxes you owe.

Contributions that are eligible for a tax credit are donated directly to schools, not to the state and not even to the school district. The funds are not subject to budget limits that prevent schools from spending more than a fixed amount for programs. Increased funding will allow more children to participate in activities.
